Eriez' Sump Cleaner rapidly removes fluid, sludge and chips from the sump, filters the sludge and chips from the fluid via the reusable integral filter liner, and returns the filtered fluid to the sump. A polypropylene filter sleeve filters to a nominal 50 microns. For finer filtration, a single-use paper filter sleeve (to 20 microns nominal) can be inserted into the chip basket.

The Sump Cleaner is fast! In just ten to fifteen minutes, a CNC machine tool sump with 50 gallons of coolant and 20 pounds of sludge can be completely cleaned with the filtered coolant returned to the sump.

Here is how our 30 day demo works:

Issue A 30 Day Demo Purchase Order: You can start your 30 day trial offer by sending us a purchase order. You must write on the front of this purchase order, "For 30 day trial." This purchase order will be used for freight charges, the price of the unit should it be purchased, and/or any return freight charges and refurbishing costs. Your Responsibilities: Your only responsibilities are freight charges and, if you should decide not to keep it, refurbishing costs as required to restore the Sump Cleaner to its original condition.

You are responsible for cleaning the sump cleaner, any refurbishing necessary and all damages incurred during use of this sump cleaner.

Demonstration time frame: An invoice will be sent with the equipment, payable net within 30 days. The demo period is 30 days from date of equipment receipt.

Equipment retained beyond the 30 day demo period and subsequently returned will be subject to a rental fee of 25% of the purchase price per month.
